Herings book was never mentioned any potency He writes "A cured symptoms only has never such an intrinsic value as one produced and cured and yet, such one should not be ignored, in course of time it may added to the characteristics. Of course all characteristics will be found here and many other symptoms produced and cured which further experience may warrant us in making up in degree until they attain the

grade we denominate characteristics".
