

Lichen planus is a condition that can cause swelling and irritation in the skin, hair, nails and mucous membranes. In a case Apis Mellifica was prescribed, it is a remedy prepared from the honey bee used mainly to relieve inflammation of skin ailments characterized by great redness and swelling. The symptoms are often better with cold applications or cool air. In this case it does not have genetic disorder of any liver disorder; it is supposed to be an acquired problem cured with homoeopathic treatment.

LP is characterized by recurrent, pruritic papules that are polygonal, flat-topped, and violaceous and can coalesce into plaques. Apis Mellifica is a remedy prepared from the honey bee

She was my old patient and taken homoepathic medicine for other ailments in past. Her presenting problems were seen by many skin specialist and they diagnosed it as Lichen planus simplex and given allopathic drugs for two years i.e. 2018. since There was no much with improvement these drugs. All complaints are recurrent with increasing intensity.

She was alright two and half years ago. Gradually she was feeling itching all over body with appearance of rash all over body. During allopathic treatment she also gains weight of 10 to 14 kg within these two years.

**Family History:** Father is diabetic on regular medicines. Mother has no medical illness. No skin problem to other family members.

**Past History**: mouth ulcers treated with homoeopathy medicines in past with no recurrence.

### **Physical Generals:**

➢ Built: Robust, stout

- Appetite Increased. Diet: only vegetarian
- > Thirst- small quantity t long interval
- Sleep- Disturbed due to itching
- Throat- Uvula was also looking swollen with minimal stinging pain
- Mouth (Tongue)-Red swollen with vesicles, gums are also swollen
- > Desire- Milk and its products
- ➤ Aversion- Sweet,
- Extrimities: Swelling on both upper and lower limbs with pitting oedema on both ankles.

### **Physical Examination:**

- > Temp. Afebrile
- ➢ Pulse Rate: 85 bpm
- ➢ BP: 126/86 mm of Hg
- ➢ Wt.- 95kg

**Prescription:** APIS MEL. 30 three dose on day first was given with placebo for next 15 days.

# Follow Up:

1. She had stopped all allopathic medicines after starting homoeopathic medicines. After 15

days i.e. Jan.2021 there is marked decrease is pruritus with fresh feeling. Placebo was given for next 15 days.

- In feb.2021, there is no facial puffiness. Also reduced pedal oedema. Most important that she was sleeping whole night without interrupt. So she was happy and looking satisfied. No repetition of dose only kept on placebo for next 15 days.
- In March 2021, she felt that she lost her excessive body weight with 5 to 6 kg and it was around 86 kg. So she was much exited.
